THE LATEST NGN UPDATES

Earlier this fall, Elsevier's NGN experts Donna Ignatavicius and Linda Silvestri answered common questions we receive from faculty and during our other NGN live webinars. Below is an overview of some of the primary topics they covered.

Item Types and Item Content

Q: Will the case study or scenario be repeated with each question in an unfolding case study?

Each case study or scenario will be repeated with each question in an unfolding case study so the test-taker will not need to remember the case.



Q: Any updates on decreased number of specialty topic questions on NGN for OB and pediatrics?

The exam is based on client needs and percentages, not on specialty areas. Most questions are adult health—however, there are OB, pediatrics, and mental health questions on the exam. All activities are listed in the test plan.

Item Writing and Application

Q: What do you recommend for how to implement the new NGN item types throughout the curriculum?

Faculty should introduce new item types after students learn how to utilize the six clinical judgment cognitive skills of the NCSBN Clinical Judgment Action Model (Layer 3 of the NCJMM). You should have students practice new items as ungraded assignments, then gradually add them to exams. You can read more about this in the NGN rollout plan. On exams, faculty can begin adding familiar-type items like Multiple Response and Multiple Choice within unfolding cases. Over time, faculty can add other types within unfolding cases to exams. Then, add stand-alone items (Bow-tie and Trend) to exams.

Q: What data collection tools do you recommend using in clinical for learning how to Recognize Cues?

Faculty should include more on focused assessments as part of Health Assessment course or Foundations content, as well as use clinical scenarios. It's important to teach fewer physical assessment skills but help students achieve competence. Clinical agency tools can also help for admission or shift assessments.

Specific Item Type Logistics

Q: Should instructions be included in every question?

For all NGN items, clear directions need to be included. Here are some examples from the NCSBN:

- Which of the following actions would the nurse take?
 Select all that apply.
- **Drag** the top 4 client findings that would require follow-up to the box on the right.
- **Click to highlight** the statements in the transfer report that require action by the nurse.
- Complete the following sentence by using the list of options.

Q: Are there questions in a Select All That Apply (SATA) that have only 1 answer?

For Select All That Apply questions, there can be one correct answer, more than one correct answer, or all options can be correct. There will be at least five options and no more than 10 in a SATA question. For Select N questions, it tells the test-taker the number of items (N) that can be selected.

Scoring

Q: How will the new NGN test items be graded?

There will be 3 scoring methods depending on which type of item is being scored.

- **0/1 scoring:** 1 pt. for correct response, 0 pt. for incorrect response; score is sum (e.g., Bow-tie, MR Select N).
- +/- scoring: 1 pt. for correct response, -1 pt. for incorrect response; score is sum but no less than zero (e.g., MR SATA, Matrix MR).
- Rationale scoring: 1 pt. when both responses in pair are correct; 0 pts. if they are incorrect (e.g., Drop Down Rationale, Drag and Drop Rationale).

Shadow Health and the Student Performance Index™

In Shadow Health's Digital Clinical Experiences™ (DCEs) for undergraduate courses, students practice one round of the NCSBN Clinical Judgment Measurement Model (NCJMM). They assess their patients and then create care plans using ICNP nursing diagnoses. By completing a patient exam and a care plan activity within a DCE, students apply each cognitive skill in Layer 3 of the NCJMM. At the end of each simulation, students see a score that represents their clinical reasoning and can also be used as a grade.

Care Plans, which are now part of every applicable product in the Shadow Health undergraduate catalog, allow students to practice key skills that will be essential to success for the NGN. Care Plans offer experiential learning that prepares learners to practice making clinical judgments. After completing their patient assessment, students create their Care Plan by selecting an appropriate nursing diagnosis and supporting evidence, planning a short-term healthcare goal, determining appropriate interventions, identifying data collections to assess whether their goal was met, educating the patient about their plan, and evaluating their plan's success. We are updating our Care Plans based on ICNP style of nursing diagnoses statements to better align with the NCSBN Clinical Judgment Measurement Model (NCJMM).
